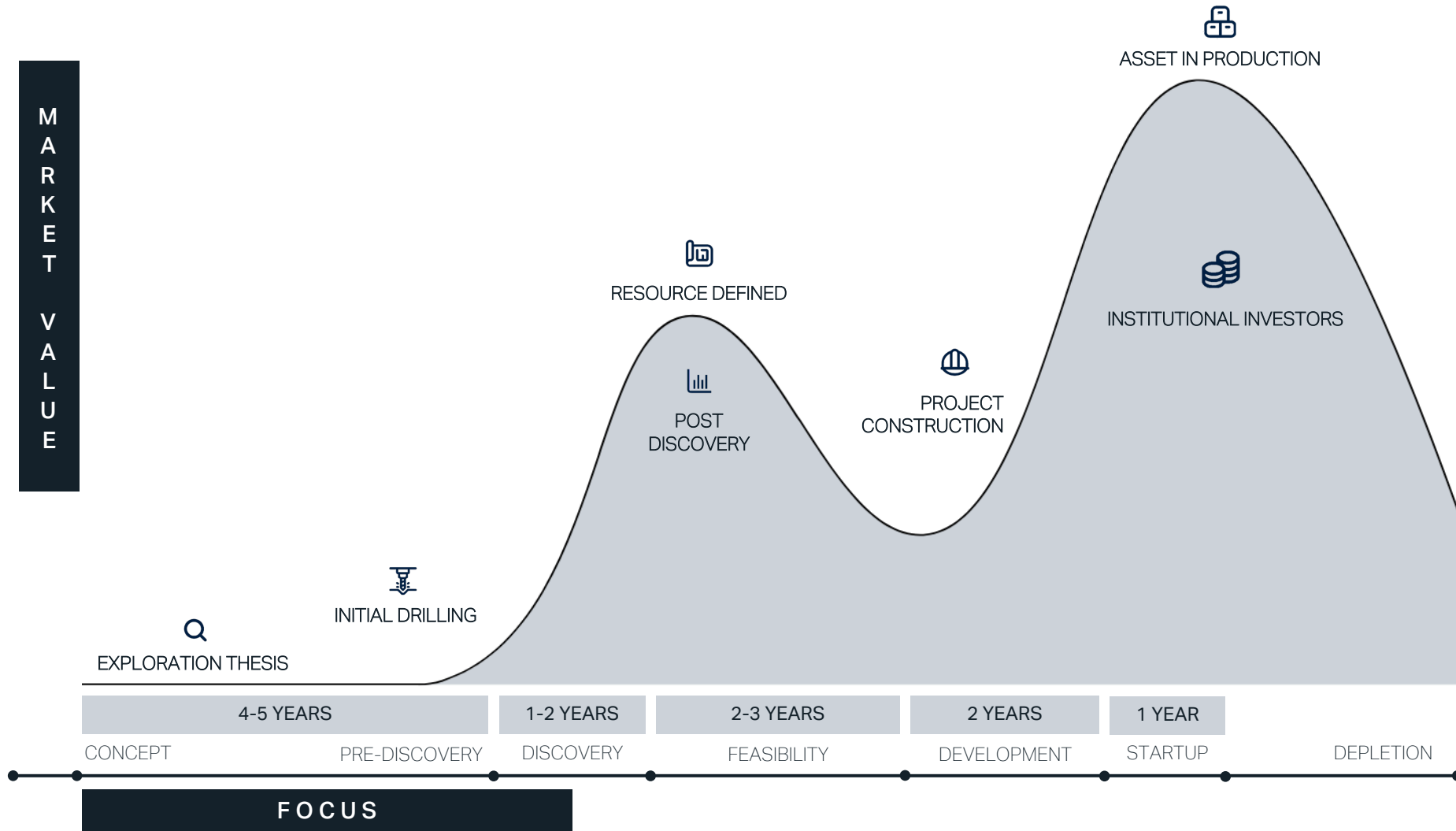

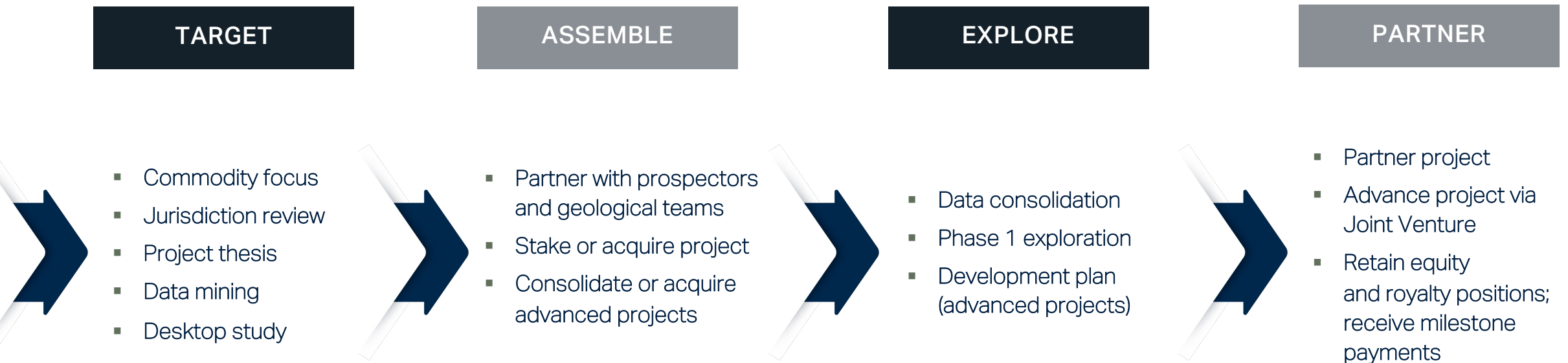

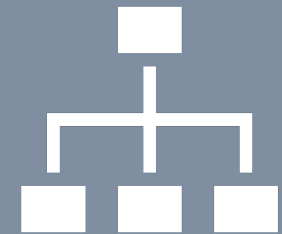

# Current Initiatives

## Rediscovering Canada's Untapped Uranium Potential Central Mineral Belt, Labrador

- Canada's forgotten uranium jurisdiction
- Host to multiple large undeveloped uranium resources
- Variety of styles of uranium mineralization
- Minimal exploration since 2008 when an exploration moratorium was imposed to settle land claims and land use issues (moratorium lifted late 2011)
- 260 x 75Km under explored belt of rocks, host to widespread uranium mineralization

# Current Initiatives

## A High-Purity Key to the Low-Carbon Economy

### Silica – British Columbia, Labrador

- Essential for transitioning to a low-carbon economy
- Potential replacement for graphite in batteries
- Vital for solar, semiconductors and high-tech industries
- Proximity to infrastructure and end market
- Abundant mineral but high purity silica is rare and a key component in the high-tech supply chain
